- 1. Council receives and notes the information in this report for the proposed completion of Infrastructure Projects Upgrading of the Swimming Pool Amenities and Facilities.
- In accordance with the provisions of Clause 178 (1) (a) of Local Government (General) Regulation 2021 under the Local Government Act 1993, the amended tender submitted by Precinct Commercial Pty Ltd, in the Recommended Tender Amount for the rescoped works with air conditioning to be included of \$1,089,888.58 (excluding GST), be accepted for <u>Contract No. C13-82</u> for the Upgrading of the Swimming Pool Amenities and Facilities, Warren NSW.
